This Amendment extends Categories 15.2.2 and 18.3.1.1. for two years expiring June 30, 2024.
 - Establish a June 30th termination date for all CALNET NextGen contracts to align with the fiscal year to streamline the contract extension and renewal process.

All other terms and conditions remain the same.
