

ATTACHMENT 3 – ADDITIONAL CONDITIONS

Pursuant to the PMAC General Provisions – Telecommunications Section 81, Disentanglement (Migration-Out) the CALNET 3 shall be extended for a period of 24 months starting January 1, 2022 through December 31, 2023 to allow customers more time for contract migration. During the 24-month transition period customers shall migrate services from CALNET 3 to the CALNET NEXT GEN Contract. During this extension for CALNET 3 migration-out the following stipulations shall apply:

1. Existing customers can utilize CALNET 3 to order services, conduct moves, adds and changes during the migration-out period;
2. All CALNET 3 Authorization To Orders and Individual Price Reductions shall remain in effect until the customer's migration-out process is complete; and
3. For services not being renewed on the CALNET Next Gen contracts, the CALNET Program and CALNET 3 Contractors will work with customers to ensure all services are migrated off CALNET 3 contracts on or before December 31, 2023.
4. Upon completion of customer transition and migration of all CALNET 3 services, this contract may be terminated per PMAC General Provisions – Telecommunications, Section 26. *Termination for the Convenience of the State*.

Pursuant to the terms of the CALNET 3 contract Special Terms and Conditions, Section M, Migration-Out, the state reserves the right to extend the contract to ensure Contractor completes the migration out process.
