**Subject:** RATE ADJUSTMENT FOR FISCAL YEAR 2024-25

The California Department of Technology (CDT) is implementing rate adjustments for Fiscal Year 2024-2025, which encompass rate increases in several services. As always, CDT endeavors to minimize the impact of these adjustments on our customers to the greatest extent possible.

The following rate adjustments will be effective July 1, 2024.

# CDT Services - General Salary Increase (GSI) Rates Adjustments

The GSI Rates Adjustment is CDT's proposal to increase the billing rates used to recover the costs to provide services funded through the Technology Services Revolving Fund (TSRF). This across-the-board adjustment is necessary to offset the increase in personnel salary and benefits costs projected to be incurred by CDT services. CDT is required to cost recover for the services provided to customers by charging for services consumed based on approved and published rates.

ISIM is a complimentary Identity Management product suite that provides extended controls, role-based user management and provisioning for users in ISAM, and other repositories such as Active Directory (AD) and Resource Access Control Facility (RACF).

## **Unix Solaris Server:**

The Unix/Solaris Application Hosting Service provides customers standardized Solaris server and operating system configurations, deployment, management, and administration of Solaris-based software applications allowing customers access via the Internet or through the CDT network. CDT offers virtual server hosting for Application Hosting customers. As of December 1, 2024, the California Department of Technology (CDT) is sunsetting the Solaris Platform Hosting Service due to the age, platform, and lack of skilled resources to maintain the system. Therefore, CDT is proposing to pass all associated costs to the last remaining customer, the Department of Motor Vehicles (DMV), as a direct charge.

#### California Managed Cloud (CAMC):

California Managed Cloud (CAMC) provides customers with managed services within CDT's public cloud account. Customers can select from Infrastructure as a Service (IaaS) or Platform as a Service (PaaS) services that leverage the public cloud features and functions. Because this service is built in a native public cloud environment, customers will have the ability to access an ever-expanding catalog of features and services as they are released from the cloud service providers. Customers can also select from Pay-per-use or reserved instances for better cost management of their managed service environments. Deployment and management of resources in CAMC is fully automated allowing for quicker provisioning and remediation in the event of an incident. The service is scalable to meet application demands and fit the customer's business requirements. In addition to traditional x86 (Windows or Linux IaaS VMs), CAMC offers the ability to use PaaS instances to support their business applications and needs. This will allow for quicker provisioning and lower total cost of ownership, as there is no Operating System (OS) to maintain in the PaaS service offering.

This service is behind the CDT managed network and firewall infrastructure. Customers can create virtual machines (VMs) that are unmanaged with an unlicensed operating system (OS). UCS is scalable, reliable, and secure, and provides CDT customers with the opportunity to boost IT agility, flexibility, and service to its customers and to the business. UCS laaS is a subscription-based service with no minimum commitment.

#### California Government Enterprise Network (CGEN) Infrastructure:

The CGEN Infrastructure service provides the statewide network infrastructure that supports the CGEN. This infrastructure includes three interface hubs (iHubs) and the inter-connecting circuits. Each iHub is in a different geographic location and local access transport area (LATA) for redundancy and fault tolerance. One iHub is in Sacramento, another in the Bay Area, and the third in Southern California. The CGEN Infrastructure service also recovers the staff costs for on-going management of CGEN vendors and customer use. The iHubs are the gateways to resources located at CDT and to the internet. Most of the State Government's internet access service is provided by the iHubs. The iHubs work together to provide a central point that coordinates the State's network access over multiple service providers. The iHubs are used to monitor the ability to reach each remote site and they are positioned to scan network packets for hostile events.

The remote access VPNs allow mobile workers and telecommuters to take advantage of broadband connectivity. The CDT customers are responsible for obtaining their own Internet service provider. CDT provides a high-performance, scalable, and robust VPN infrastructure to support the customers' mission-critical, remote-access applications. The CDT infrastructure provides the highest encryption available and can support a wide range of client software. This VPN platform offers Scalable Encryption Processing (SEP) modules, which enables users to easily add capacity and throughput.

## Server Load Balancing and Enhanced Server Application Delivery Service:

Network servers are frequently used to host enterprise resource planning, e-commerce, and a myriad of other applications. As a result, the web has been embraced by many departments as an inexpensive channel to communicate and exchange information and transactions with customers. The availability of these applications is often threatened by network overloads as well as server and application failures. Resource utilization is often out of balance, resulting in the low-performance resources being overloaded with requests while the high-performance resources remain idle. Server load balancing is used to solve the problem of performance and accessibility for distributed application systems. The load balancer provides the ability to direct application users to the best performing, accessible server. Additionally, all this data must be somehow captured, stored, processed, and transmitted to be used immediately or later. Security breaches on these kinds of applications are a major concern because it can involve both enterprise information and private customer data.
