## Cellular Services available through CALNET for K-12 Schools

#### **OVERVIEW**

CALNET Program offers Cellular Voice and Data services via competitively bid State contracts available to local government entities. Public schools can utilize these contracts by completing the Two-Step Registration Process. Once registered, schools may contact their chosen CALNET contractor sales representatives to submit their service orders.

### **CELLULAR SERVICES AVAILABLE ON CALNET**

The CALNET Cellular contracts offer multiple standard service plans, as well as an array of plans offered under the "Customized Service Plans (CSP)" product ID. For K-12 schools, Distance Learning promotions may be available from the CALNET vendors under the CSP product ID. For these special plans, K-12 schools must contact a provider's sales representative to purchase.

### **CALNET REGISTRATION PROCESS FOR K-12 SCHOOLS**

**Step 1** – K-12 public schools are required to submit a completed Non-State Entity Policy Agreement (NESPA) to the CALNET Program via email to <u>CALNETHelp@state.ca.gov</u>.

**Step 2** – K-12 public schools are required to submit a completed Authorization to Order (ATO), which obligates all parties to the terms and conditions of the CALNET contract. The ATO form(s) shall be submitted to the CALNET Program via email to CALNETHelp@state.ca.gov.

# **ORDERING SERVICES**

Schools submit a Purchase Order directly to their chosen CALNET Contractor, in accordance with their own procurement rules. Ordering documents shall not be submitted to the CALNET Program.
