# PowerPoint Presentation – Scott Adams, Deputy Director for Broadband and Digital Literacy

Deputy Director for Broadband and Digital Literacy Scott Adams gave an overview of the Office of Broadband and Digital Literacy; explained the roles of the State Chief Technology Officer, the CDT Chief Administrative Officer, and the Department of Finance in execution of Broadband Middle-Mile Initiative; and detailed progress to date on the middle-mile activities.

State CIO opened the meeting for questions from members. CPUC Commissioner Martha Guzman Aceves introduced herself, and Assemblymember Jim Wood asked a question about coordination.

### Agenda Item 3 Middle-Mile Guiding Principles

#### Presentation of Guiding Principles by Scott Adams

Scott Adams presented the three Guiding Principles to be adopted by the MMAC. Principles adopted by consensus to provide a clear direction to staff.

- 1. Provide affordable, open-access, middle-mile broadband infrastructure to enable last-mile network connectivity throughout the state.
- 2. Build the network expeditiously, leveraging existing infrastructure, networks, and construction projects, where feasible.
- 3. Prioritize connectivity to unserved and underserved communities, including community institutions.

### Agenda Item 4 Information Items

#### Update from Department of Finance

Department of Finance provided an update on State and Local Fiscal Recovery Funds from federal government.

#### Update from CPUC and Caltrans on Mapping

CDT, CPUC and Caltrans are working closely on mapping middle mile locations and finding overlap with transportation projects. Also looking at stand-alone projects where there is no overlap.

#### Update from CPUC on Public Comment

CPUC explained process to make public comment on proposed middle-mile locations.

#### **TPA Update**

CDT described progress on obtaining a third-party administrator that will manage development, acquisition, construction and operation and maintenance of the middlemile network. The State CIO opened up the floor for questions from members.

Senator Gonzalez asked about download speed of 100 Mbps download speed and designation of unserved vs. underserved.

Assemblymember Quirk-Silva asked about coordination with small districts and areas that have no or very little access.

Assemblymember Wood echoed comment about 100 Mbps download speed and asked for more detail on what unserved and underserved areas look like, and put harder to serve areas ahead of areas that already have some service.

Senator McGuire made comments surrounding prioritization of service starting with unserved and moving to underserved.
