






Statewide there are 200+ Agencies and 200K+ Employees.

- Starting in 2025, we now have 357 State Members across 66 State Entities.




Membership on the rise.




How connected do you feel to the Community of government GIS users?

How connected do you feel to the community of government GIS users... *Column Bar Pie Map



What current activities of the community of practice do you find more useful?




If the CoP had subgroups for specific topic areas, which of the following would you like to join?




